## **Director's report:**

We have had a busy year with meetings taking place most months. John Hughes retired as Chairman and Kevin Reilly was elected to the role at the HQ AGM.

Headquarters are getting their staff back into the office and Ian Embelton's job is being advertised and we should be in a better position to give an update on this in December.

The new website for headquarters is up and running and has been for about a month now although some things are still being moved over and this should be complete early next year.

Next year's calendar is in place. It was asked if any information has come in with regards to the views on Covid19 and the situation of the branch.

George Watson's College asked if it would be possible to split the contest into an AM and PM event with and some bands attending in the afternoon with bands going home after they have performed.

### **Music Board Report**

- The MB have agreed to discuss further the letter being sent to the BoD regarding their concerns about MB resignations. Both letters and other information to be tabled at next MB meeting before any further action.
- An external third party had asked the MB if they could publish the MAP tunes on their website which is a commercial site. An initial and subsequent response has been sent to explain the reasons this can't be approved by the RSPBA.
- The World Solo Drumming Group prepared a press release which has now been published with all dates and venues for the new Adult Solo drumming circuit. These can be found on the RSPBA Web and Social media channels. Please like and share the Social Media posts if you can and ensure all Adult drummers within your bands are aware. These new Championship tilted events also carry qualification to the World Solo Drumming semi-final events per the normal rules.
- The MB suggest the BoD review the survey to bands re the UK Indoor to decide next steps, (75% of the respondents believe the event is a good idea (to date, 52 responses - 159 invites, although less say they would be able/ready to enter)
- All other MB projects are ongoing. This includes the G1 World Pipe Band Championship development and the Docuseries.
- Following the Music Board survey and previous social media press release in 2020 and as intimated at the RSPBA 2021 Association AGM, the Novice Juvenile B and Grade 4B *static start* will be piloted at the Championship in Inverness- 2022, the All Ireland and the minor competition(s) prior to that date. As additional support, a member of the MB is hoping to provide an explainer video. However, bands should refer to the original announcement of the pilot and/or contact their Music Board Rep for further information. Please continue to remind all bands and if possible, can we highlight the pilot as a reminder via our Branch Social Media channel.
- The Playing requirements for the season 2022 have been prepared by the Format Group, approved by the MB and form part of the MB Report to BoD for the 4<sup>th</sup> December and subsequent publication. Adjustments have also been discussed and prepared by the Format Group if required because of Covid rule changes that might affect practise arrangements. This element will be reviewed and presented if required.
