Board of Directors Feedback -

Minutes of the BoD were issued on the website on the 24th October and were accepted as being read by the MB members.

Standards & Gradings Group – a meeting was held by the S&G group to discuss the appeals we had received to our 11_{th} September grading changes. Appeals from the bands were agreed and all bands have been notified and a news item was to be created.

Grading Appeals approved by Board of Directors:

West Lothian Schools upgrading from NJA to Juvenile – Appeal accepted, band will remain in NJA Brisbane Boys' College Australia upgrading from G4A to G3B – Appeal accepted, band will move back to NJA Edinburgh Academy upgrading from NJB to NJA – Appeal accepted, band will move back to NJB George Watson's College NJA to Juvenile – Appeal accepted, band will remain in NJA George Heriots School NJA to Juv – Appeal accepted, band will transfer players to maintain NJA and Juvenile bands

Brisbane Boys' College Australia G4B – Band will move back to NJB

World Solo Drumming Group -

WSD met with VC over telephone. The new solo drumming championship circuit for 2023 will have 6 Qualifiers from the RSPBA Scottish, British, European and UK championship events and 4 qualifiers from the RSPBA Intercontinental and Pacific championship events. This will produce the 32 semi-finalists as there will be no morning qualifier on the day of the Final.

The two requests to hold future qualifying events will go to the WSD to discuss. Tunes Group – work still ongoing. Refreshed to see this year that newly created settings for some of the tunes was being used. JM working on new drumming scores (had 35 to write).

Format Group –

The Format Group held a brief zoom meeting on the 2nd November.

Two discussion points – the cut-off point for qualifiers and playing requirements progression. Decision made that too late to carry forward any changes for the 2023 season (other than the Grade 1 MSR change) and that as it is an FG project it should follow the stages of an FG Project and we should bring the proposals to the branches (stage 2). 2023 playing requirements will stay as per 2022 (other than Grade 1 MSR) and the FG need to meet to set the requirements.

AF raised issue if Majors were cancelled and no MSR was played (for example) in the run up to the World Championships then could we change the playing requirements. MH answered that there is a clause on the playing requirements news item that states that the requirements are subject to change.

The MB agreed that the FG members should meet (immediately after the meeting) to agree the playing requirements for the 2023 Majors in preparation for the next board meeting.
