#### Matters arising:

## Secretary's report:

A list of Branch bands not having pair their affiliation fees to the RSPBA was read out. Some bands have since paid their fees since the publication of the list. Those who have not are to be contacted by the Branch secretary.

## Treasurer's report:

Headquarters have asked for two bank statements. John Hughes is to take them through at the next National Council meeting on 5<sup>th</sup> February 2010.

#### National Council report:

Some championship trophies are to be replaced.

There was a delay in receiving the minutes from the Music Board.

The playing requirements for 2010 were agreed. Details are on the RSPBA web site.

Merchandising is to be done by a company called B.I.G. for the next two vears.

The competition list was approved.

All majors except the Worlds will start not earlier than 10.30 am.

Changed to the company by guarantee are to be ready for the RSPBA AGM. A tenor and bass contest id to be held in the week of the Worlds. No venue has been selected yet.

The Music Board are to discuss the rules governing a tenor and bass contest as none exist.

Glasgow and West of Scotland Branch and Stirling Branch have requested to run the Bridge of Allan competition.

#### Music Board report:

A questionnaire for grade one bands is to be sent to all UK grade one bands. Dual registration of leading drummers was discussed.

Grading appeals were read out. Those concerning L&B Branch are Linlithgow & District to stay at grade two. A new band, Stockbridge, is graded grade 4B. Bo'ness higher to lower transfers agreed. All these changes are subject to ratification by the National Council. Standards group do grading now.

The PDQB drumming representative is Arthur Cook.

13 PDQB students have passed their exams. 13 have passed their instructors course.

#### Trophy Converor'sreport:

George Watson's College won 54 trophies and Boghall & Bathgate Caledonia won 44 trophies in the 2009 season.

It was agreed that The Royal Regiment of Scotland should pay their fine for late return of trophies as other bands have been fined for such an offence.

Wilma Dalziel is to write again to The Royal Regiment of Scotland. John Hughes is to speak to the Executive Officer on this matter at the next national Council meeting and ask that a formal letter be sent. Under RSPBA rules bands are suspended from playing until fines have been paid.

#### Steward's report:

The death of Jim Martin was announced. Jim was a member of Ayr, Dumfries and Galloway Branch.

New tents demonstrated at the last steward's meeting were deemed unsuitable for use by the RSPBA. New tents are now being sought.

There will be only one ring at Innerleithen.

## Education report:

There are five piping and four drumming students. The course started on 17<sup>th</sup> January 2010 and will run until the exams on 28<sup>th</sup> march. A venue for the exams is to be sought.

Income from the course is approximately £1400. Expenditure is approximatey£1300. This is a rough estimate as the cost of venues and books have not been included.
