There had been a news article issued on HQ Website advising guidance on return to practises.

### **Education Group Report**

35 – 40 students took part with 19 sitting the final exam who all passed. There was great feedback from participants. Further exams dates will be organised for later in the year.

We are hoping to run courses for the higher levels in September/October.

### **Music Board Report**

- The Music Board met on the 11th of June
- The mini festival workstream is progressing with a series of short documentaries. The documentaries will be broadcast on the RSPBA official channels where input from the APMB, College, Individuals, Bands and the top 6 solo drummers is currently being planned and scheduled.
- The Music Board have expressed their unanimous dissatisfaction about certain items which appeared within the Board of Directors minute of the 29th May. Specifically, items related to online competitions which contradict previous agreements. Also, the reason that the alternative model for online wasn't used at a particular event. The Music Board feel overlooked and on occasions having their work redirected is causing frustration. As result, clarity of Board of Directors roles and decision-making responsibilities has been sought.
- Standing Orders and Grading have met and would request that any Band which feels they might be requesting re-grading to make contact in the usual way through HQ. Any request for re grading's must be sent and accompanied with an up-to-date band registration form and clearly state the reasons for request. Bands should also note rule 3.28 and if applying for a downgrade that they must be prepared to compete in two further contests in their existing grade prior to decisions being given. However, the more information submitted the better to aid the process the better. Bands are also reminded of the 42-day rule and rule 3.71. All request should be submitted as soon as possible.
- The Music Board have approved a proposal from the World Solo Drumming Group that the Regional Qualifiers now carry a national title. For example, Scottish, British, European, UK and Intercontinental. The Lothian & Borders Branch who are currently approved to host a regional qualifier are offered the opportunity to host the Scottish title. Going forward the titles can be rotated as can the branches bidding.
- The playing requirements across certain grades are currently being reviewed. This is with a view to increase the requirements in the future.

### **Trophy Convenor Report**

### **Branch Contests**

All Branch contests have now been cancelled for the 2021 season. All Promotors are keen to hold contests in 2022. There will need to be funding obtained for Dunbar and Edinburgh. It was suggested that more advertising for the Edinburgh contests is needed, and the President will take this up in his discussions with Edinburgh Council.
